Dear Sponsors:

Welcome back to another school year! Everyone on the VJAS Committee is looking forward to working with you and your students. We welcome Michael Lovrencic as Vice-Chair of the VJAS Committee and Robin Curtis as Associate VJAS Director. There are a few procedural reminders and some significant changes to paper formatting requirements to point out to you. Please take the time to read the VJAS Handbook (http://vias.org/handbook.html) for more detailed explanations and guidelines. A chart summarizing the handbook updates has been included at the end of this document for guick reference.

Important Dates

- Membership Fees are due by January 15, 2020.
- VJAS Paper Submission Deadline is Wednesday, February 19, 2020.
- Applications for Special Awards are due by April 30, 2020.
- 2020 Symposium will be May 27-29, 2020 at James Madison University. Due to JMU's summer school schedule, the Symposium will occur Wednesday, Thursday, and Friday with student presentations occurring on Thursday, May 28, 2020.

Paper Formatting

- Printing: Single-sided OR double-sided
- Paper Length: 14 pages (14 pieces of paper printed single-sided or 7 pieces of paper printed double-sided)
- Line Spacing: No less than 1.5 and no greater than 2.0
- Forms may also be printed double-sided

Safety

As you and your students begin your journeys in science please always keep safety at the forefront of any experimental planning. Projects that may seem simple can have very real and very serious safety hazards. Here are a few reminders:

- The SDS for any chemical that students will be using or producing in any experiment should be read prior to experimentation to ensure proper protection is used.
- Projects that require the interaction with human subjects for the purposes of data collection, no matter how small or simple the interaction, require informed consent from every subject.
- The use of devices such as power tools and other 'household' appliances have their own safety concerns that must be addressed.
- Please locate within the designated area of the paper your safety procedures.
